

Fraud Alert Subscription Service

Protect yourself from Fraud with the Clerk's Fraud Alert Service

A Fraud Alert Subscription is a free public service offered by the Pinellas County Clerk's office to you help detect fraudulent documents recorded with your name into Pinellas County Official Records.

FBI says property and mortgage fraud is the fastest growing white-collar crime. Property Fraud is when someone illegally uses your property for financial gain. This entails someone recording a fraudulent deed and/or lien against your property in the Official Records of the Pinellas County Clerk's office. The Fraud Alert Service will notify you of any document recorded in your name, property or otherwise.

Although the alert system does not prevent the actual fraudulent activity from taking place, it does provide an early warning system to alert subscribers. Subscribers armed with this notification system will be able to take prompt, appropriate action if they determine the activity to be fraudulent. Signing up requires only your name!




